Permission to close the following streets from 7:00 AM to 6:00 PM has been granted by the South Carolina Department of Transportation:

Congress Street from Jefferson Street to Madison Street
Madison Street from Congress Street to Roosevelt Street
Roosevelt Street from Madison Street to East Liberty Street
East Liberty to Jefferson Street from 7:00 AM to 10:00 AM (5K /Fun Run)

As a downtown business owner, we hope you will participate in SUMMERFEST. Please note that each business owner is given a space for his or her use during the festival. If you do not wish to participate, or you do not return the application by the deadline, the space will be assigned to a craft or food vendor for the day of the festival. Also, spaces are only given to businesses that are currently opened and are to be used only by the business owner. Spaces cannot be given to another person to use the day of the festival. Buildings occupied by two businesses must share the space.

On the day of the festival, for safety reasons please make sure the sidewalks in front of your business are kept clear. It is not our intention to disrupt anyone's business on this busy day and we will try to work with any business owner who has any questions or concerns about parking, as well as, entrances/exits on the day of SUMMERFEST.
